Wind Energy Ordinance: Continuation of discussion regarding modifications to sections of existing ordinance. The following action was taken on modifications to the ordinance that were originally proposed at the July 6, 2017 PC meeting.

Section 6.50 Wind Energy Conversion Facilities, Subsection (g) (1) (B). This section will be amended to read:

1,320 feet or 4.0 times the total height, whichever is greater, from the property line of any non-participating parcel.

- **A.** 45 dBA LAmax or the ambient sound pressure plus 5dBA, whichever is greater, for more than 10% of any hour measured outside and immediately adjacent to any occupied structure which was located on any participating parcel at the time a permit for the WECF was issued;
- **B.** 40 dBA LAmax or the ambient sound pressure plus 5dBA, whichever is greater, for more than 10% of any hour measured outside and immediately adjacent to any property line on any non-participating parcel at the time a permit for a WECF is issued;

Section 6.50 Wind Energy Conversion Facilities, Subsection (g) (8), by adding the following two sentences at the end of the paragraph which is the entirety of this section:

All turbines are to be equipped with a shadow detection system. Shadow Flicker on non-participating parcels shall not be allowed.
